It also has its own website so you can instantly start making money 24/7 from the World Wide Web!

PHASE 1:

The Phase 1 income from your new Bonus Company has been much higher than any other single company you own. The reason is simple; it provides a much better business opportunity than any one single business. When your customers purchase this opportunity from you, they become Printing Dealers for you and will be getting a complete printing business that they can profit from without the normal burdens associated with a traditional printing business.

They won't need to buy and/or maintain expensive printing equipment. Did you know that it can run over \$100,000 each just for some of those commercial copiers! They won't need to mess with hiring or training employees. They won't need to rent retail space or deal with the normal expensive overhead of a normal printing business which can really cut into a business owner's profit.

This retail discount allows your dealers to offer discount printing services to the public at prices that are below the national average. This makes it easy for them to generate business and be successful.

This 25% to 50% discount off published prices is your profit margin. You simply split this however you want with your printing dealers. They usually get the bulk of it since they are doing all the work. For example, with a 25% profit margin which is usually for General Products such as business cards, brochures, envelopes, postcards, letterheads, etc. - you may decide to give your dealers 20% and you keep 5%. This means you collect 5% of the retail sales from hundreds of printing companies all over the country.

The sales literature used in The Science Of Debt Elimination & Art Of Prosperous Living program has been exhaustively tested and upgraded to produce excellent results, although, it doesn't produce near the income as your Bonus Company.

People that purchase this business opportunity from you get both a product to sell as well as a product that is guaranteed to make them a millionaire. It takes the complicated world of investing and simplifies and explains it in the most beneficial ways. Much more than simply a budgeting and investing tool, this program has a proven roadmap that shows step by step how ANYONE can become totally debt free in as little as 5 years, including their mortgage, using nothing more than their present income and without sacrificing their lifestyle – and then shows them exactly how to retire as a totally debt free millionaire!

PHASE 2:

Phase 2 of this business opportunity results in a continuous flow of income from all your customer's retail sales of the program. They become Distributors for you and will be selling The Science Of Debt Elimination & The Art Of Prosperous Living to Retail Customers. While they do all the work, you receive a percentage of the total sales from all your Distributors combined. All your customers become Retail Dealers for you. It's like having a bunch of Franchises all over the country from which you make money on the combined sales of all of them. They then rated each business opportunity in several categories such as ease of use, required skills and/or resources, additional investments, earning potential, etc.

Instead of wasting money (not to mention the mental frustration) buying one business opportunity after another only to end up disappointed, frustrated, and poorer, they can now have absolute certainty. With a single purchase from you, they can get all the inside details of the business opportunities that are usually only revealed after they are purchased. You do NOT need to own a computer, have Internet access, or know anything about “advertising” to make tons of money! You'll learn exactly how I made millions marketing the very companies you now own – it's very easy to do!

I'll even supply you with all the Sales Literature (personalized for you) very inexpensively so you can start making money right away. Simply see the order form located towards the back of this manual.

Your Bonus Company is by far the easiest because when the orders (and payments) start coming in you simply deposit the money into you're your bank account, forward the customers order onto us, and we'll take care of everything else for you without it costing you a dime out of your pocket! You can even have someone else forward the orders for you so you can be off on vacation while your bank deposits are being made automatically to supply you with plenty of money!

If you decide to advertise on the Internet, your Bonus Company has its own Website that is ready to accept Online orders from your customers and send all the Fulfillment materials back to them electronically.

That's it in a nutshell – your job is done (or I should say “done for you!”). Now let's break each step down into detail so you know exactly how to do everything, or again, how to have it all done for you...

Marketing Your New Business Opportunities:

Again, your Bonus Company is by far the easiest to market and produces the most income, but the marketing strategies you'll learn here can be applied to all the business opportunities you own so you don't have to learn different strategies for different businesses.

There are several different types of strategies you can use to advertise your business opportunities to potential customers. I'll go over each one for you and give you my personal experience with each. This is very important, because I'm not going to simply lecture you about things I may have read about – my advice to you comes from years of success and making a lot of money (tens of millions of dollars) with the exact same companies you now own!

Advertising your business opportunities can be quite fun and easy. It's extremely exciting to see a successful advertising campaign start, grow, and bring in lots of customers and lots of money. Advertising doesn't have to cost a lot of money, or any money for that matter.

There are many profitable advertising strategies that you can, and should take advantage of – some are free, some cost a little money, and some cost a lot of money. You don't necessarily “get what you pay for.” Just because some advertising is free, doesn't mean it's bad. Likewise, just because some advertising is expensive, doesn't mean it's good.

Most of the time (not always) free advertising will require a little more effort on your part.

I'll let you know which advertising strategies (some free, some inexpensive, and some expensive) that I've used to make millions of dollars. I won't tell you to limit yourself to using just these methods, but you'll most likely want to start out using them. I can't say that I've tried every good or bad promotional tool available, but my experience can at least make you a millionaire and that's not a bad place to be starting.

You'll always want to test new advertising methods, new mailing lists, new companies, and so on. When testing anything new, you'll always want to test it on a very small scale to see how it produces.

Let's first take a look at advertising that utilizes the Mail because this is where I made tens of millions of dollars – you just can't beat the Mail! There are several different types of advertising promotions that are done through the Mail. Each one has its advantages. They also have a lot of similarities and don't require any hard work – only because your Sales Material is already completed, tested, & perfected!

CARD DECKS:

There are several card deck companies that you can contact to promote your business opportunities. A card deck is made up of many (50 – 100) post card sized advertisements. They have enormous circulation, usually anywhere between 100,000 and 300,000 circulation.

Card decks allow you to send your post card size advertising to hundreds of thousands of people looking for a business opportunity at a fraction of the cost it would be for you to mail it out individually. Card deck advertising is also a two-step method of selling your business opportunity.

The post card is intended to get people interested enough in your business opportunity that they will send away for more information. Once they mail the postcard back to you, which has all their mailing information on it, you simply send your complete sales package back to them.

You'll want to keep their mailing information for your "In House Inquiry List." An "Inquiry" means they simply responded to your offer and not necessarily purchased it. Many people from your Inquiry List will jump over to your "In House Customer Mailing List," which are the people who purchase your business opportunity.

Both of these lists become very important. In fact, I traded my list of names for a lot of free advertising. In fact, I started out with a card deck mailing to 150,000 potential customers without it costing me a penny.

This was my first type of promotion way back when I didn't have a dime in my pocket. After I took the business plan given to me and developed a business opportunity from it, I contacted another company that sold business opportunities. I agreed to trade "Inquiry Mailing Lists" with them.

They agreed to give me 15,000 of their inquiry names so that I could get started. Our offers were completely different so I wasn't competing against them and it didn't cost them anything but a computer disk. In return, I would give them my first 15,000 inquiry names as they came in. They realized that it could take me a few months to come up with the names, but again, it didn't cost them anything.

Of course, I didn't even have enough money to send out 1 envelope, let alone 15,000! So I took the 15,000 names and traded them to a card deck company for 1 insertion in their 150,000 circulation deck. They designed my post card for me and I was off and running.

This two-step method of advertising is the same whether you utilize card decks or classified advertising in a magazine or newspaper. I never used much advertising in newspapers since it was too difficult to target people wanting to start their own business.

As soon as I could, I started using Direct Mail because this is where the “real” money started coming in ... and fast!!!

DIRECT MAIL:

Direct Mail advertising can be one of the most lucrative ways to sell your new business opportunities. It does cost some money, but it can be started small and quickly build. It can be one of the quickest and most successful ways to put money in your pocket. Even with the Internet available, don't discount Direct Mail just because it may cost a little to a lot of money. Many times, Direct Mail is used in conjunction with a Website. For example, mailing out Postcards with your Website address on them. This can cut down greatly on your printing expense. The customer can visit your website to get all the details about your Business Opportunity, and then print out their order form directly online to mail back to you with their payment. You can also take this a step further by Personalizing your Website allowing your customers to order directly online using a Credit Card, Debit Card, E-Check or PayPal. There's a small cost to Personalizing your website, but the extra income that online sales produce is well worth it. You'll find more information on Personalizing your Website on page 46. I would say, about 85% of my advertising was Direct Mail.

I started out with mailings of 500 letters. This quickly grew to mailings of 5,000 then 10,000 then 20,000 and up. There are companies called Mailing Houses that do all the work for you. We can recommend some when you need them, and believe me; you'll need them faster than you think.

I always tested new lists when the quantity was 5,000 or more, and I recommend you do the same because the majority of your costs will be in postage and printing. You don't want to mail out to all 5,000 names – not until you test it first. You'll want to randomly

select (the mailing house will do this for you) 10% or 500 names from the list and mail to those names only.

This random test will give you a good idea of what you can expect from the entire list. If the response is poor, you can safely bet the entire list will be poor. If you get a good response, by all means, mail to the rest of the entire list at once. Once you've tested a list and it passes that test, you don't need to test it again in the future as it renews itself with fresh names.

Mailing list companies can be found in your Yellow Pages or on the Internet if you have access. Be sure to find one that specializes in Business Opportunity / Opportunity Seekers lists.

Your Direct Mail piece is composed of 4 items which we supply you with (very inexpensive & personalized for you) for each and every multi-million dollar company you own. 1. A Sales Letter which explains your business opportunity in full detail and makes the offer to your customer so they can purchase the business and send you money. 2. An Order Application which the customer uses to order the business opportunity and gives you their mailing and payment information. 3. A #10 Mailing Envelope which you use to send your offer out to all your potential customers. 4. A #9 Return Envelope which is printed with your mailing address and is what your customer uses to send the order and payment to you.

If you take advantage of your Bonus Companies Ready-Made Website, you can simply mail small Postcards with your Website's address on them. Your Website address can also be included on your Order Application and #10 Mailing Envelope in traditional Direct Mail marketing.

There are some costs involved with Direct Mail, the two major ones being printing and postage, but the potential of a successful Direct Mail promotion can be phenomenal. You only need a small rate of return to make a lot of money. Return rates as low as 4% to 6%

can mean tens of thousands of dollars for you off a single promotion. I once bought a new Convertible Corvette and my license plate read simply ... “5%”.

This means that even though 95 out of every 100 people who got my offer for a business opportunity decided to pass it up, and only 5 people out of every 100 decided to take advantage of it – I still made enough money from Phase 1 alone to pay cash for a new luxury sports car! I put “5%” on the plate because that was my rate of return on that particular Direct Mail promotion. Return rates will always vary from promotion to promotion. I’ve had return rates from the very low of .2% to over 12%. Your break-even (the return rate you need to cover all your expenses) will generally run around 2% or so and the rest is all profit!

For small mailings, it’s easy to do it yourself. This can be done in the evening time while watching your favorite show or movie on TV. It’s much harder to do this under a tarp in the woods with no TV to keep your mind occupied, but it only has to be done in the very beginning so it’s no big deal. The rewards are phenomenal – now I get to enjoy a 110” giant screen movie theater in my house. Anyway, back to business - unless you’re able to do a fairly large Direct Mail promotion at first (5,000 or more) and then you can simply have a Mailing House do it for you.

Mailing Houses can be found in your local yellow pages, or again, online. For a very small fee, they “stuff” your envelopes – meaning they insert your Sales Letter, Order Application, and #9 Return Envelope into your #10 Mailing Envelope, then seal it, address it, stamp it, and take it to the post office for you. Direct Mail promotions are completely hands off for you. We can also recommend a mailing house for you to use.

INTERNET ADVERTISING:

The Internet is a tremendous way to market just about any type of business, but it has to be done right in order to be successful. The Internet has a lot to offer in free and low cost promotions that can make you a lot of money. Your Bonus Company has lots of

items available to capitalize on what the Internet has to offer such as a Turnkey Website for Online Orders, Email Ads, Squeeze Pages, Postcards, etc.

Before I get into some specifics about Internet marketing, let me first say that Internet advertising is not the “only” way to make a lot of money selling your business opportunities. Some people want you to think that the only way to succeed is through the Internet and to forget about the other marketing strategies. If this was true, I wouldn’t have wasted the time to tell you about Direct Mail. Fact is, I made tens of millions of dollars before I ever started using Internet advertising. Of course, millions of dollars can, and has, been made on the Internet as well. In order to make the most money, it’s very wise to combine Direct Mail and the Internet for maximum earnings!

Let me say that there is a lot of worthless information being sold and distributed on “how to advertise on the Internet.” Most of it is garbage that is simply passed on by people who don’t know any better because they’ve never actually tried it.

An Email list is very similar to a Direct Mail list. It’s simply a list of people who may be interested in what you are selling. It’s quite easy and inexpensive to rent an email list of people looking for a business opportunity.

Make sure you only rent “opt in” or “permission based” email lists. If not, your email is considered to be “spam” or unwanted email. An example of such a list is simply a list of people who authorized a person or company to email them information on business opportunities by providing their name and email address. People on these lists always have the option to stop receiving such emails at any time.

One of the best email lists you can have, and receive a much higher income from, is one you create yourself. This also makes it free.

To build your own “opt in” list can be very easy, but does take a small amount of time. The most common strategy is to use what’s called a “Squeeze Page.” A squeeze page is

simply a single web page that has the sole purpose of capturing the person's name and email address for follow up marketing – nothing else. A squeeze page is not intended to sell anything so nothing should be on it that costs money. Once you have the customers email address, then you can send other emails pertaining to anything you may have available for sale.

A squeeze page usually provides a News Letter or some other type of “subscription” for which they sign up. It can also provide a one time Report or other information to help the web visitor. The design of a squeeze page is very important. Just as important as the sales literature for anything you're charging money for because even though the item is free, a squeeze page must “sell” or persuade people to voluntarily give you their email information in exchange for whatever you are offering for free.

It is also important that what you are offering for free is top quality and has real value to it. This is where a lot of people fail by using the garbage information being sold in so many “E-Book” offers currently on the Internet. If your free offer is relatively worthless, your potential customer will most likely think anything you're selling is of poor quality as well.

Many people search the Internet for free stuff. If your free stuff is high quality, then your customer gains trust and respect for you and your company. If they're impressed with your free stuff, they'll be anxious to purchase whatever you are selling.

Another powerful advertising strategy is mailing a Postcard that gives enough information to persuade your customers to visit your website for complete information regarding your business opportunity. This method combines the strengths and benefits of both Direct Mail and the Internet to compliment each other in a very profitable advertising technique.

The Personalized Website for your Bonus Company is able to take and process all your customer orders online automatically 24 hours per day, 7 days per week, all year long

using Credit/Debit Cards as well as E-Checks and Pay-Pal so there's absolutely nothing you have to do except enjoy being the owner and let your Website & the Internet do all the work for you!

Getting Paid:

When you receive a cash payment, it doesn't matter. However, when a customer sends you a check or Money Order, they need to know whether to make it out to you personally or to your company name.

You can find a lot of information about different types of company entities such as Sole Proprietorship, Partnership, Corporation, etc. but my recommendation is to start as a Sole Proprietorship so you don't have to spend lots of money on an attorney to file all the paperwork required with every other business form. You can always incorporate later on (when money's no problem) if you decide it's best.

It doesn't really matter if you use a company name or not. If you do use a company name, you'll most likely need to set up a separate bank account in the company name. You can always simply add the words, "& Associates" to the end of your name so it looks like a company and the checks can be deposited into your personal bank account. This would allow you to have a "company" name but not require you to set up a separate bank account to deposit checks made out to "your name & associates." For example, my company name would simply become, Michael Forbes & Associates.

MANAGING CUSTOMER SALES & RECORDS:

You Can Skip This Section If You Are Starting

Your Bonus Company Because We Do All This For You!

If you don't want to worry about managing customer sales and records, you'll want to start your Bonus Company because this is all handled for you making it incredibly easy for you to start making money!

Otherwise, you'll want to keep track of all your customers, the people who send you money. You can do this without a computer – I did.

If you don't have a computer, don't worry. Like I said, you can hire companies to do all this for you. It won't cost you a penny out of your pocket because they take just a few cents out of the money the customer sends you. For example, if the customer sends you \$29.95, a company will record your customer's sale for just a fraction (usually just a dollar or two) of the money. We can recommend companies that will do this for you if you wish – again, we're here to make everything easy for you!

If you have a computer and want to do it yourself, any Database program will work. You don't need anything fancy and all Database programs come with instructions on how to use their particular program, so I'll just let you know what information you want to keep track of regardless of which program you use.

The DATE you received the payment.

The TYPE of payment (Cash, Check, Money Order, Credit Card, etc.)

The AMOUNT of the payment.

The PRODUCT ordered.

Your customer's NAME, ADDRESS, CITY, STATE, and ZIP CODE.

The DATE you ship the customer's order or forward it to a company doing it for you.

CUSTOMER SERVICE:

You Can Skip This Section If You Are Starting

Your Bonus Company Because We Do All This For You!

If you don't want to worry about providing any customer service or contact information to your customers, you'll want to start your Bonus Company because this is all handled for you making it incredibly easy for you to start making money!

Otherwise, when selling your business opportunities, customer service is very important. It won't require much since the fulfillment materials cover most everything. Still, you'll want to have an address or a fax number or email address (having all 3 is ideal) that customers can use in case they have a question or need some help.

You can also hire this out (as well as everything else) to make it super easy for you. There are companies that specialize in providing customer service for companies. They can provide you with contact numbers, including a toll free 1-800 number if you want to provide one. These companies tend to charge quite a bit for their services, however, when the time comes that you'll need them, you won't have to worry about money.

You'll notice that in each of your company's fulfillment manual, I've left the Customer Service Contact Information blank so you can fill this in with the correct information (or we can do this for you) before you distribute them to your paying customers. Your "Bonus Company" does not require this since Customer Service is handled for you.

You'll also want to provide a mailing address for customers to use for sending letters. This can be your physical address or a P.O. Box that you obtain from the Post Office. This will also be used if your customer decides to return their purchase. Although your business opportunities have an extremely low return rate (customers who thought the business would not benefit them and return it for a refund) which is only about 1% or 2% of your customers – there's not a company in existence that doesn't get returns. Simply refund the customers money as soon as possible which means you'll want to send them their money within just a few days of receiving their return. It will take some time to process it, but you don't want to let it sit for several weeks before handling it. The amount you send should not cover the S&H fee which is generally never covered under refunds. The same companies that provide customer service will also provide return service for you.

Again, we take care of all this for you with your Bonus Company.

THE EASIEST & QUICKEST WAY FOR YOU TO MAKE MONEY:

Obviously the quickest and easiest way for you to start making money (and the most) is by starting your Bonus Company first, then your other companies shortly thereafter.

For advertising through the mail and making money in Phase 1 (as you'll remember, from the bank statements – making \$1,000 per day is not unusual) you can choose between the Postcard (I would recommend a Personalized Website be used with Postcards) or the Sales Letter along with personalized order applications which will have your name (or company name) and address on them so the customer will send their money directly to you; so that you get your profits up front and daily (no waiting on monthly checks). Along with the Sales Letter and Order Applications, you can also use your very own personalized envelopes. These are nice because it makes your company look more professional and will increase your sales.

All of these materials are on the Product Order Form located on page 44. Longer Sales Letters produce a higher response because they give more information, but they also cost more to print. One way to reduce this cost is to get your companies Website and use it in conjunction with the Postcard (very inexpensive) and let the Internet do the selling for you. The sign up sheet for your Website is located on page 44. We'll discuss how to use these materials in more detail in just a bit.

In Phase 1 of your Bonus Company, your Net Income is almost 50% of the total sale, and we pay for all the fulfillment costs, overhead costs, and customer service so there's absolutely nothing you have to do – everything is handled for you by us.

In Phase 2, your income will be a guaranteed 25% of the combined and total commission sales generated by all your customers from Phase 1. In Phase 3, your income will be up to 70% of the fees generated from the combined and total sales made by all Credit Card, Debit Card, or E-Check from each and every sale made at any time in Phases 1 and 2!

GETTING STARTED:

Basically all you have to do is use the strategies I showed you in the Marketing section of this manual to get your Sales Letters into the hands of people who are looking for a business/income opportunity. It's that simple to start making tremendous amounts of money from your new Bonus Company. Hundreds of thousands of dollars has been spent testing and perfecting this copyrighted literature to give you amazing and proven success!

ORDER PROCESSING:

Processing your orders is VERY IMPORTANT! Once you receive a customer's order and payment, you must forward it on to us no later than one week from the time you receive it. We will then fulfill the order by shipping your customer the complete Business Opportunities Owner Package. This way, you don't have to worry about stocking inventory, packing boxes, shipping costs, printing costs, etc. We recommend setting aside one day a week (Saturday for example) when you take all the orders you received that week and mail them to us in one envelope.

When a customer sends you a payment of \$77.00 for The Business Opportunities Owners Package, you will keep \$37.00 and send Information Brokerage Services, Inc. (IBS, Inc.) \$40.00. When you forward all the orders you've received during the week to us, you can write just one check (or send a money order) for the total **made payable to IBS, Inc.**

For example, let's say one week you get 100 customer orders for \$77.00 each. That totals \$7,700.00 ($\77.00×100) for the week that you will deposit into your bank account. Your profit is \$37.00 per order so the amount you will keep would be \$3,700.00 ($\37.00×100) and the amount you would send to IBS, Inc. (along with all customer order applications) would be \$4,000.00 ($\40.00×100). We will then take care of all the overhead costs involved with printing, packaging and shipping the materials to your customers. We will also handle all the ongoing customer support costs for your customers.

Remember, it is very important that you forward your customers order applications and payment (less your profit) to us absolutely no later than one week after you receive it! Keeping the order longer can cause problems with your customers due to the delay. This can result in frustrated customers canceling their order and wanting a refund. We will process and ship your customer orders generally within a couple of days after receiving them.

PROMOTIONAL MATERIALS:

Any and all materials you'll need to generate sales in this business can be easily obtained directly from IBS, Inc. In fact, due to copyright laws, you must obtain all the Sales Literature (only for your Bonus Company) from us. You will find the "Product Order Form" towards the back of the manual that you'll want to pull out for that use. Keep in mind that we've spent hundreds of thousands of dollars and years of market research putting together the best Sales Literature & Materials money can buy, just so you can be as successful as possible.

We will personalize these materials for you by printing your name (or company name) and address on the order applications and envelopes. You will see an area on the Product Order Form to fill in the name and address you want printed on your materials. We can also print your Website Address on these as well.

You may decide to put just your name, for example: "John Doe" or you can make up a company name such as "Doe & Associates" or "Doe Financial Services". It doesn't really make a difference; it's simply a personal preference. The same is true with the use of a Post Office Box. Some people find it easier to process business mail using a PO Box rather than their home address. Keep in mind that customers will be making their payments payable to whatever name is on the order application, so if you choose to use a company name, you will need a business account in that company name at your bank to cash the payments. If you don't have a business account in a company name at your bank and if you don't have a PO Box then it would be best just to use your personal name and home address on all your materials. You can always change to a company name and PO Box address at a later date.

People don't like to re-invent the "wheel of success" and you don't have to because we've gone to all the trouble and expense of perfecting the Sales Literature to bring in a most impressive response, resulting in the highest profit possible! Furthermore, our product satisfaction rate is extremely high which creates very happy customers.

Every once in a while you will receive a bad check from someone. Bad checks are just a part of business. It's an extremely low percentage and nothing to be overly concerned about, so don't hold personal checks for bank clearance as the delay may upset the 99% of people who send you a good check and are expecting their materials promptly. If you do get a bad check from a customer simply send them a copy of the bad check along with a short letter asking them to reimburse you for those funds. Also, please advise us of the situation so we can put a hold on their companies until they make good on their payment to you.

Here's a little additional information on marketing your Bonus Company just to get you off to a good and profitable start! Although there is some duplication, this information is a supplement to the Marketing section of this manual so be sure to read both!

DIRECT MAIL:

Direct mail is very responsive and somewhat inexpensive to begin. Because of its responsiveness, it is very easy to expand your business and increase your income. For example, if you mail out 100 Sales Letters a week, you can easily start taking a portion of your income from those "small" mailings and start mailing out 200 Sales Letters a week and "double" your income. You can then easily "stair step" your way to higher and higher incomes and level off at the amount you're comfortable earning.

As we discussed earlier, the success of direct mail marketing hinges a lot on obtaining a good mailing list. You'll want to look in your local "Yellow Pages" probably under the heading of "Advertising-Direct Mail" and/or "Mailing Lists" or something similar. You can also find many Mailing List companies on the Internet. Simply "Google" the words "Mailing List" and you'll find all sorts of companies with all sorts of mailing lists. You will have a wide variety of mailing lists to choose from so the best thing to do is tell the Mailing List broker that you are offering a "legitimate" home based business/income opportunity and they can usually recommend a good list to use. As well as any lists they might recommend we have also found that "Business (or Income) Opportunity Buyers or Seekers" are great lists to use. If you have a choice between Business Opportunity

“Buyers” and “Seekers” always choose “Buyers” as those are people who have actually purchased an income opportunity before and are therefore more likely to invest in another one (especially if it is as good as ours), whereas “Seekers” have shown interest in business opportunities before, but may not have actually purchased one.

The pricing and quantity of lists available will vary depending on the company. The cost for a list of 500 to 1,000 names will usually range from about \$30.00 to \$100.00. You can always eliminate the risk involved with direct mail by “testing” a new list. Do this by mailing out to a random selection of 10% of the names. For example, if you have a list of 500 people go through and randomly select 50 people throughout the entire list and mail them a sales brochure and order application. The results you get from those 50 people are an excellent indication of what you’ll get from the rest of the list.

The materials you’ll want to use for direct mail advertising are a #10 Personalized Mailing Envelope, #9 Personalized Return Envelope, a Personalized Order Application, and a Sales Letter. Again, you can order these supplies using the product order form on page 44. You’ll also want these materials even if you start with a 2-step method of marketing such as a Card Deck so you have the Sales Literature to send back right away to your customer’s when they request it.

It’s always best to order these supplies first (before the mailing list) because it will take a little while for us to print and personalize your materials (normally just a couple of weeks, but you should allow about 4 weeks). Once you receive your sales materials and while you are waiting for the mailing list to arrive, insert the Sales Letter, Order Applications, and #9 Return Envelopes into the #10 Mailing Envelopes. When your list arrives, simply address the mailing envelopes. The customer will read the Sales Letter to learn about the offer, then fill out the Order Application and use the #9 Return Envelope to send it back to you with their payment.

As you expand your mailings to larger quantities you can have a “Mailing House” do all the inserting, sealing, and addressing of your letters for a small fee, which totally

eliminates all the work on your part. You can find Mailing Houses in your local Yellow Pages under “Mailing & Shipping Services” or something similar. When using a mailing house to do the work, you can simply order your mailing list and have the list company send the list directly to the mailing house. When ordering your sales material from IBS, Inc., we can ship the materials directly to the mailing house as well. The mailing house “stuffs” all the envelopes, puts the mailing labels on, and mails them out using their bulk rate postage permit. You never touch an envelope! Remember those huge bank statements I showed you, this is exactly how I made a lot of that money – tens of thousands of dollars per week!

It’s very easy to start small and build up to larger and larger promotions each time using just a portion of the profits (you got to have fun while you’re doing it or what’s the point) to pay for everything.
